## Who we are . . .

In 1976, the County of Riverside Board of Supervisors established a temporary Committee on the Status of Women, which was made permanent in 1978. In 1983, the committee was elevated to commission status. In 1987, the name was modernized from Commission on the Status of Women to its current title of the Commission for Women.

Ten commissioners are appointed by the Board of Supervisors - two per district. Commissioners represent a wide range of backgrounds, interests and experience.

In its work for women, the Commission, part of a network of local, state, and national commissions, focuses on a variety of concerns. These include child care, violence against women, legal rights, legislation, housing, problems of the aged, single parents, medical care for women, prenatal care and sexual harassment. A goal of the Commission is to promote diversity within the community.

**Annual Highlights for the period July 1, 2007 - June 30, 2008**

**Summary:**

The Women's Commission was successful in 2007/2008 in setting and accomplishing its goals and objectives. The Commission annually identifies issues and/or concerns that affect the status of women, and then seeks to increase the visibility of those issues, or make recommendations, to minimize the impact of these issues on women in Riverside County. Annually, the Commission also holds a symposium/luncheon to provide education and information through open dialogue. The Commission carefully selects topics that will hopefully affect change in the lives of women, and create partnerships that will last a life time.

The Commission in its attempt to address women's issues set forth an aggressive agenda, and was successful in all areas.

The Women's Commission selected the following goals and objectives for Fiscal Year 2007/2008:

- 1) Review and update Commission's By-laws;
- 2) Revise the Commission's Bylaws to add a Budget Officer to the Commission;
- 3) Sponsor a Public Hearing for Community input on local issues;

- 4) Create criteria, and select an outstanding Woman of the Year for each Supervisorial district;
- 5) Create criteria, and an approval process by which the Commission issues a certificate of endorsement for those events and/or issues that are in alignment with the Commission's goals; and
- 6) Create an appreciation packet for guest speakers.

Fiscal Year 2007/2008 brought about new faces and new challenges. The new chair person, Lori Stone, began the year with challenging the Commissioners to review the Bylaws to ensure clear communication and understanding of the bylaws, and to also review the language to ensure potential inconsistencies are clarified or removed. Revision of the Bylaws began in January 2008, and a Form 11 was prepared and submitted to the Board of Supervisors in March 2008. On April 8, 2008, the Board of Supervisors approved the addition of a new Budget Officer position, and approved additional revisions requested by the Commission.

On Thursday, June 19, 2008, the Riverside County Commission for Women held its first Legislative Forum (public hearing), held in the Board of Supervisors Chambers. More than forty testimonies from individuals, government agencies and non-profits spoke before the Commission about issues that pertain to women and children in Riverside. This hearing not only accomplished the goal to seek community input on local issues, but also created an environment for positive networking. The Commission will follow-up with action, and present a testimonial document to the Board of Supervisors no later than October 1, 2008.

The Commission also sought input from the Community for its outstanding Woman of the Year recipient. The Commission began with creating criteria in preparation for the selection process. Applications were distributed and reviewed against the criteria. Upon review and final recommendation, the Commission selected one woman from each district to receive this distinguished honor. On April 8, 2008, the Commission hosted its annual Open House and Luncheon where awards were distributed. The Commission presented the Outstanding Woman of the Year to the following recipients:

- Dr. Kathleen Wright, District 2
- Carol Roquemore, District 3
- Carmela F. Garnia, District 4
- Debbie Franklin, District 5

The Commission also created criteria for a "Certificate of Endorsement" for non-profit and/or agencies, and those events and/or issues that are in alignment with the Commission's mission. In September 2007, the Commission awarded its first endorsement to the Susan G. Komen for the Cure "Passionately Pink" event.

Lastly, in order to create ongoing visibility, and provide outreach materials to the community, the Commission created an appreciation packet for all speakers, and/or dignitaries that participate in Commission events.
